Q. Is there any Policy or Norms or regulatory memorandum has passed that First Author as well as corresponding author must be Principal Investigator or Project Leader of research article or review paper or book chapter or patent?

A. According to ICAR guidelines on publications, point number 1.3, implies IP sharing of authorship among the regular staff of the institute (**Citation:** ICAR. 2006. ICAR Guidelines for Intellectual Property Management and Technology Transfer/Commercialization. Indian Council of Agricultural Research, New Delhi). In most of the cases the Project Leader (PI) based on the leadership offered in executing research agenda, majoring intellectual input and shaping the research output is identified as first author or corresponding author. In case Co-PI exerts similar mandate, he is given first author as ICAR guidelines says the authorship should truthfully reflect individual's contribution to the reported study. This clause is implied among the permanent staff. A memorandum issued to all the contractual staff recruited in the project such as project assistant, JRF/SRF/RA the norms are spelt out in Memorandum issued are mandatory at the time of employment offer. On agreeing the terms and conditions they are admitted. It points out clearly that they don't have any claim on data generated during the course of their work during the project period/patents/any IP generated. Because of the discretion of PI, they are given authorship keeping in view that would help in their career.

Q. Even though any Project Assistant, JRF, SRF and Research Associate has contributed major research fully conceptualization, experimental performance, data acquisition, data analysis and interpretation and writing manuscript for publication cannot be considered as First Author as per ICAR regulation or their institutes.

A. As far as the temporary contractual staff are concerned *i.e* recruited in the project, such as RA/SRF/JRF/Project Asst. are meant to implement the already conceptualised and designed research on a given topic which is laid out in the project document, its objectives, activities, methodology conceived and outputs already outlined in the project document in line with the vision provided by the PI and for attaining the institutional goals which is approved and sanctioned by the funding agencies. The intellectual input is constantly provided and results are regularly monitored, bringing in protocols and mid-course corrected analysis or repeating a particular activity, while the project staff involved in operationalisation of it, data taking, analysis and preparation of draft. Further, the output involves IP that belongs to ICAR institute. The outputs either research publication or any other cannot be led by the temporary staff whose average tenure is six months or so. Therefore, either PI, or CoPI or other permanent staff will hold the first authorship. However, based on discretion and consideration of the project staff efforts, they are given co-authorship as a due recognition. While as per ICAR guidelines either Ph D or M Sc students are allowed to publish in journals from their thesis work as the first author. All the students (at least 10 nos) who worked under Dr Dayakar has published research with concerned student as first author.

Q. Although major research work contribution acquired by researchers or students why always Dr. B. Dayakar Rao have First Author and Corresponding Author but refused to give First Authorship who major contributed.

A. It is not true that Dr B Dayakar Rao, is always the first author as his permanent colleagues in the institute too bear the first authorship. When the research work involved Dr Dayakar Rao and the project contractual staff, it is true he holds the first authorship by virtue of his contribution and he being the custodian of holding IP of the institute as permanent employee

and not vice versa. Other permanent staff including scientists who worked with him has already come up with publications as first authors in more than half a dozen cases. Many papers with Dr Dayakar as PI has second or fourth author such as Dr Ratnavathi, KN Ganapathy; Drs Rajendraprasad (NIN), Manisha Guha (CFTRI) The recent one is Dr. Shivshankar, scientist who was deputed from IOPR, Pedavegi for Institute attachment training bears first authorship on publications with respect to research on "Degree of polishing in millets". However, it cannot be RA/SRF/project Assistant. To sum up, the issue is not PI or PL but firstly IP must be held by a permanent employee of the ICAR institute and not RA or project staff, as the resources are deployed by the institute and secondly, truthful reflection of Dr Dayakar's individual contribution which is amply described above in point two which is in compliance with ICAR guidelines. To reiterate that terms and conditions in the memorandum issued by the head of the institute before joining this temporary service which clearly states that they have no claim whatsoever and duly agreed by all the contractual staff.

Q. Why ICAR-IIMR do not have ethical committee to resolve such act.

A. ICAR-IIMR follows the ICAR guidelines which are framed taking into all ethical and institutional interests.




