1. The above posts are purely temporary and on contractual basis till the end of project period. The selected candidates **shall not claim for regular appointment/absorption in ICAR-IIMR** or funding agency at the end of the project.
2. The age limit of above position is up to 35 years as on the date of interview. The relaxation in upper age limit is five years for SC/ST/women candidates and three years for OBC candidates as per rules.
3. The eligible candidates are requested to send their duly-filled in bio-data in the enclosed application format '*Annexure I*' and '*Annexure II*', along with self-attested scanned copies as single file (PDF/JPEG) of the relevant documents by e-mail to balakrishna@millets.res.in on or before **30th April, 2024**. Incomplete application and/or without proper certificates will be summarily rejected.
4. For short-listed candidates' interview will be held **virtually via Zoom Platform** on **06th May, 2024** at 10:00 A.M onwards. The online reporting time for interview will be communicated individually through Zoom link. The candidates shall adhere to the instructions and timings of joining the virtual interview. The candidate/s may be required to wait for the access as per the waiting list and the details of which will be communicated through email.
5. The candidates are advised to ensure good internet connectivity for the smooth conduct of the interview and download the relevant software (Zoom) to connect the link, IIMR doesn't take any responsibility if someone misses interview on these reasons
6. All the relevant original testimonials (date of birth, degree certificate, experience certificate, etc., if any) are to be shown and a set of attested copies of all the certificates will be required to be

submitted by the candidates for verification, before joining, if selected. If any candidate is found to have submitted false information/claims at any stage, their candidature will be summarily rejected and appointment will be terminated if found during project period.

7. No objection and experience certificate are required from the employer; in case he/she is employed.
