TENDER NOTICE FOR SALE OF UNSERVICEABLE ITEMS ON “ AS IS WHERE IS BASIS”
TERMS AND CONDITIONS OF BIDDING

Open bids are hereby invited on behalf of Director, IIMR for the disposal of unserviceable items on “as is where is” basis. **The unserviceable items can be inspected between 2.30 to 4 PM from 08.07.2019 to 20.07.2019** on all working days. The terms and conditions are given below:-

TERMS AND CONDITIONS:

1. The offer should be accompanied by crossed Demand Draft for Rs.40,000/- (Rupees Forty thousand only) towards earnest money deposit in the form of DD in favour of “ ICAR Unit IIMR, Hyderabad” payable at Hyderabad.
2. The interested party should submit their tender (in the Proforma enclosed) to the undersigned in double sealed over. The outer cover should be super-scribed with the words “QUOTATION FOR UNSERVICEABLE ITEMS” **due on 20.07.2019**. The bid should be addressed to the Director, Indian Institute of Millets Research, Rajendranagar, Hyderabad 500 030i and be deposited in the tender box kept in the office of AAO(s), IIMR Hyderabad on or before **20.07.2019 at 13.00** positively. This office shall not be responsible for any delay in postal transit. No bid shall be accepted after the due date and time. If the due date is declared as Government Holiday, the bid due date will be next working day at the same time noticed as above.
3. Bids should be signed by bidder/himself / themselves or a person duly authorized in this behalf. A copy of such authority should be enclosed along with the offer.
4. Bid forms are not transferable.
5. Bidders can inspect the unserviceable items during office hours upto **20.07.2019 between 2.30 p.m. to 4 PM**. in regard to the conditions, of unserviceable items and satisfy themselves before submitting their offer by the date and time specified above.
6. Overwriting or alternations will also disqualify the bid unless these are legible attested by bidder/ bidders.
7. Rate should be kept valid for acceptance at least for **180 days** from the date of opening.
8. Other levy if any will have to be paid by the successful bidder.
9. It will be presumed that the bidders before submitting the offer have read carefully all the terms and conditions and accepted the same in full. Deviations from the terms and conditions as given in this are not permitted. Any such conditional bid and / or telegraphy bid is liable to be rejected and no alternations shall be allowed after the bid is submitted. No counter terms and condition shall be accepted.
10. Right to include any other conditions or modify or alter any of bid conditions already stipulated is reserved by the Director, IIMR, Hyderabad
11. Bidder will be deemed to have been on the clear understanding that they have satisfied themselves fully in regard to the conditions, quality and quantity of unserviceable vehicles proposed to be auctioned.

12. Sealed envelope along with the earnest money deposit should be submitted on or before 20-7-2019 upto 16.00 hrs. The envelope should be addressed to The Director, ICAR-Indian Institute of Millets Research, Rajenderanagar, Hyderabad-500030.
13. Bidders should obtain acknowledgement receipt while submitting the bids. Only those bidder who are having acknowledgment will be issued gate pass and will be allowed to participate in the bid opening.
14. The Sealed quotations will be opened on 22-7-2019 at 11.30 AM, in presence of the bidders. Only the bidders or their authorized representative with authorization letter will be allowed in the opening of bids. The sealed quotations are to be dropped in the tender box kept in the Admin section, IIMR. The envelope shall bear the title of the assignment i.e. "Bids for auction of unserviceable items".
15. The Sealed quotations without EMD will be summarily rejected. Similarly bids received after due date and time are rejected straightaway.
16. The list of unserviceable scrap items is indicated in the Part –II of the Finance Bid.
17. The earnest money deposit for the unaccepted offers will be returned after completion of the sale procedure without any interest.
18. The purchaser has to bear the expenses towards transportation, labour etc.
19. Bidding on behalf of another person will not allowed in all matters at the auction sale.
20. The bidders are requested to give their full name and address correctly at the time of signing the bid sheet along with contact telephone number. Request for change of name and address shall not be entertained later.
21. The highest bid shall be accepted by the authorized committee constituted by the Director of the institute, who shall have full authority to accept or reject even the highest bid without assigning any reason thereof.
22. The decision of the competent authority shall be final and conveyed to the highest bidders on the same day of bidding
23. The successful bidder should deposit ten percent (10%) of assessed or reserved price of the goods as bid security on the same day by cash or in the form of DD in favour of ICAR UNIT IIMR Hyderabad payable at Hyderabad as per the instructions of authorized committee of the institute. In case, the bidder fails to make this payment, the earnest money deposit shall be forfeited and the bidder shall be debarred from participating in future auctions. The total amount due based on weighment should be deposited by the purchaser within two days after adjusting 10% of bid security.
24. In case the total quantity to be disposed of cannot be taken up by the highest acceptable bidder, the remaining quantity will be offered to the next higher bidder(s) of the price offered by the highest acceptable bidder.
25. The successful bidder is to pay full payment i.e., residual amount after adjusting the bid security before lifting the goods.
26. In case selected bidder does not show interest in lifting the goods, the bid security will be forfeited and other actions initiated including re-sale of the goods in question at the risk and cost of the defaulter, after obtaining legal advice.
27. All weighments, accounting and loading of material will be done by the purchasers at their own cost/arrangement.
28. The weightment will be done on electronic weighment by taking unloaded truck/vehicle weight, then it will be loaded with material that are to be auctioned per kilogram basis. After loading the material the truck loaded weight will be taken at the same electronic weighment centre for arriving total weight. One of the authorized person from IIMR will accompany with the truck/ vehicle to verify the weight. The charges for the weightments will be borne by the purchaser.

29. The sales of unserviceable items are “as is where is basis”. Dismantling packing, loading and forwarding/transportation charges shall have to be borne by the purchaser at his own cost and risk.
30. The buyer shall be responsible for any damage that may be caused to the premises in process of a taking delivery. The decision of the Director, IIMR in this regard shall be final and binding on the purchaser.
31. In the Institute premises, the re-sale of disposed off items by the purchaser to another buyer is strictly prohibited.
32. Director, IIMR reserves the right to cancel/postpone the bidding at any time. Director IIMR also reserves the right to reject/accept any offer, including the highest bid. In such an event of rejection of bids the money already paid will be refunded to the intending purchaser without any interest, unless the same is forfeited.
33. The bidder is requested to inspect the items during the said period in advance at each location before submitting the sealed tender. Director IIMR does not take any guarantee/warranty/effectiveness of any item/stores and the principle of on “as is where is basis” shall apply.
34. In case of any dispute arising, the decision of the authorized committee of the Institute shall be final and binding on both the parties.
35. All the bidders shall be deemed to have read and acquainted themselves with the conditions of sale and given bids subject to these conditions.
36. In the event of any question, dispute or difference arising under these conditions or in connection with auction, the same shall be referred to the sole arbitration of the Director General or some other persons appointed by him. The award of arbitrator shall be final and binding on the parties to this contract.

PAYMENT AND DELIVERIES.

1. The successful bidder will be required to make full payment of bid by bank Draft drawn on any nationalized bank in favor of ICAR Unit IIMR Hyderabad payable at Hyderabad, within 7 days thereafter. Earnest Money Deposit shall be forfeited if payment in full is not made or the offer is withdrawn during the validity period. The successful bidder will have to lift the unserviceable items within seven days after depositing the full bid amount as per terms and conditions of the bid. Deliveries shall be affected against receipt of payment. Any purchaser failing to lift the material within the above stipulated period, shall have to pay ground rent @ 10% of tendered value per week. The Institute will not be responsible for any loss or damage of the unserviceable items. Earnest money deposited shall be forfeited if any purchaser fails to lift the items after making full payment and expiry of period as mentioned above. Thereafter IIMR shall be entitled to resell these items. No notice shall be issued to the bidder in this regard.
2. The purchaser will not be entitled to resell any or all – unserviceable items while these are still lying within the premises of IIMR and no delivery would be affected by any person or persons other than the purchaser/purchasers whose name/names are mentioned in the delivery order.
3. The successful bidder before actually collecting purchased unserviceable items should contact the Assistant Admn. Officer (S), IIMR, Hyderabad to get the gate pass and delivery of unserviceable items.
4. Loading, handling, labour and transportation shall be the sole responsibility of the purchaser at his own cost, rest and arrangement.
5. Loading and lifting of the auctioned goods shall be done by the purchaser only during the prescribed working hours of the Institute. No deliveries shall be affected during Sunday or Holiday.
6. The Director, IIMR, Hyderabad reserve the right accept or reject any or all offer/ bids either in full or in part without assigning any reason whatsoever.
7. If, sufficient bids are not received, the Director, IIMR, Hyderabad reserves the right to call for fresh bids. In such an event Earnest Money deposited by the bidder shall be refunded.

8.The Earnest Money deposited by the successful bidder shall be refunded in full without any interest.

9.The unserviceable items will be sold on 'AS IS WHERE IS' basis and no guarantee for its worthiness of quality will be given by the Institute. The tender will be rejected if the same is found fictitious and the Earnest Money will be forfeited.

10.The successful bidder shall be responsible for any damage that may be done to the premises while removing the goods by him. The Director, IIMR, may at his own options ask to make good such damages and buyer shall have to pay for the same on demand.
