Online Tenders are hereby invited by Director, ICAR- Indian Institute of Millets Research, Rajendranagar, Hyderabad - 500 030 for **FARM OPERATIONS WORK CONTRACT** for a period of **one year** from the date of signing the contract agreement and extendable by further one or more years subject to satisfactory performance of the vendor and its willingness to continue.

1. The terms and conditions of the contract are those contained in the general conditions of contract applicable to the contracts placed by the ICAR-IIMR as detailed in the tender forms and its schedules. Please submit your rates in the tenders form if you are in a position to furnish the requisite services in accordance with the requirements stated in the attached schedules.
2. An earnest money of **Rs. 50,000/-** must be submitted in the form of Demand Draft in favour of **ICAR Unit - IIMR - Hyderabad** payable to **The Director, ICAR-Indian Institute of Millets Research, Rajendranagar, Hyderabad 500 030 on or before the last date/time of submission**. The particulars of the earnest money deposited must also be superscribed on the top of the envelope by including the Demand Draft number and date, failing which the bids will not be accepted. Conditional bids shall not be considered. No overwriting or cutting is permitted in the tender documents. Such bids will be rejected out rightly.
3. The tenderer is being permitted to give tenders in consideration of the stipulations on his part that after submitting his Tenders, he will not resile from his offer or modify the terms and conditions thereof. If the tenderer fails to observe and comply with the foregoing stipulations the aforesaid amount of EMD will be forfeited by the ICAR-IIMR. In the event of the offer made by the tenderer not being accepted, the amount of earnest money deposited by the tenderer will be refunded to him after he has applied for the same, in the manner prescribed by the ICAR-IIMR. (An undertaking as per **Annexure ‘X’** is also required to be submitted by the tendering firm).
4. The schedules of the tender form should be uploaded with online bids. In the event of the space provided on the schedule form being insufficient for the required purposes, additional pages may be added. Each additional page must be numbered consecutively and be signed in full by the tenderer. In such cases reference to the additional pages must be made in the tender form. If any modification of the schedule is considered necessary, it should be communicated by means of a separate letter along with the tenders.

5. The tenders are liable to be ignored if complete information as required is not given therein or if the particulars asked for in the schedules to the tenders are not fully filled in. Individual signing the tenders or other documents connected with the contract may specify whether he signs it in the capacity of (i) a sole proprietor of the firm of constituted attorney of such sole proprietor, or (ii) a partner of the firm if it be partnership in which case he must have authority to refer to arbitration with ICAR-IIMR, concerning the business of the partnership whether by virtue of the partnership agreement or power of attorney or (iii) constituted attorney of the firm if it is a company.
6. If a tenderer does not accept the offer, after issue of letter of award by ICAR-IIMR within 15 (fifteen) days, the offer made shall be deemed to be withdrawn without any notice & earnest money shall be forfeited.
7. In case of partnership firms, where no authority has been given to any partner to execute the contract/ agreement concerning the business of the partnership, the tenders and all other related document must be signed by every partner of the firm. A person signing the tender form or any other documents forming part of the contract on behalf of another shall be deemed to warranty that he has authority to bind such other and if, on enquiry it appears that the persons so signing had no authority to do so, the ICAR-Indian Institute of Millets Research (ICAR-IIMR) shall without prejudice to other civil and criminal remedies cancel the contract and hold the signatory liable for all costs and damages. Each page of the tenders and the schedules to the tenders and annexure(s), if any, should be signed by the tenderer.
8. EMD must be deposited in Demand Draft in favour of ICAR Unit IIMR - Hyderabad at **The Director, ICAR-Indian Institute of Millets Research, Rajendranagar, Hyderabad 500 030**, during working hours i.e. 9.30 A.M. to 4.30 P.M. on all working days (except Second Saturday, Sunday and Gazetted Holidays) before the last date/time for submission of bids failing which bids will not be accepted. EMD must be in the form of Demand Draft payable to **The Director, ICAR-Indian Institute of Millets Research, Rajendranagar, Hyderabad 500 030**. (No cheques will be accepted)
9. The rates quoted by each firm for farm operations contract in tenders be given both in words and figure failing which the same is liable to be rejected. Tenders will be opened online by the authorised officers. Bidders have two options to participate in tendering process at the time of opening of Bids. Bidders can come at the place of opening of bids (electronically) as done in the conventional tender process or he can visualize the process online without physically being present at ICAR-IIMR.
10. Tenderer is at liberty to be present or to authorize a representative to be present at the time of opening of the tenders. The name and address of the representative who would be attending the opening of the tenders on your behalf should be indicated in your tender. Name and address of permanent representative of the tenderer, if any, may also be indicated.
11. **An amount equivalent to 5 to 10% of the estimated value of contract (as per GER 171)** is to be deposited by the selected agency/ successful tenderer as Performance Security Deposit only after receiving a communication from the ICAR-IIMR. In the event of non-deposition of the same, the earnest money will be forfeited.
12. No interest on earnest money and security deposit shall be paid by the ICAR-IIMR to the tenderer.
13. The Contractor will be reimbursed for each farm operations at the consolidated rates as detailed in **Schedule III**. The Service Provider shall abide by all the laws of land including labour laws (PF, Income Tax, GST or any other extra taxes levied by Govt.) Companies Act, welfare measure of its employees and all other obligation that is being instructed in such cases and are not essentially enumerated and defined herein, though any such bounded duty shall be the exclusive responsibility of the service provider and it shall not involve ICAR-IIMR in anyway whatsoever. Compliance of these provisions shall be ensured at the times of making monthly payments.
14. The Firm will not charge placement charges or any other account from the manpower deployed with the ICAR-IIMR. The contract is liable to be terminated, security deposit forfeited and the Contractor/Firm will be blacklisted if, at a later stage, reports are received that the Contractor/Contracting Firm has charged the manpower on any account.

**15. In case of more than one successful lowest bidders (L-1), the work/ contract will be awarded to the firm on merit which will be based on credentials of the firm as given, to the satisfaction of Competent Authority ICAR-IIMR on the basis of maximum award of farm operations work.**

16. Only those bidders who submit all requisite documents as per this tender and secure 45 marks in the technical qualification on parameters mentioned below will be declared as qualified/eligible for opening/considering financial bids:-

**a) Average turnover of the firm during last three years:-**

- i) Exceeding 10 lakhs & Upto 10 lakhs= 15 Marks
- ii) Exceeding 20 lakhs & upto 20 lakhs= 20 Marks
- iii) Exceeding 30 lakhs onwards= 25 Marks

**b) Experience of serving in Govt. (Centre/State) Departments/Autonomous bodies/PSUs/PSES/Bank & Insurance Companies or other equivalent organisations of high repute:**

- i) Exceeding 3 years & upto 5 years= 15 Marks
- ii) Exceeding 5 years & upto 7 years= 20 Marks
- iii) Exceeding 7 years= 25 Marks

**c) Total no. of people on their rolls**

- Exceeding 20 & Upto 50= 15 Marks
- Exceeding 50 & upto 75= 20 Marks
- Exceeding 75 = 25 Marks

**d) Atleast 3(three) years experience has to be there.**

e) Minimum manpower on roll of the bidder must be **20** (Twenty)

f) Each bidder shall submit only one bid for one request for proposal (RfP).

17. GST or any other tax applicable or made applicable after awarding the contract in respect of this contract shall be payable by contractor and ICAR-IIMR will not entertain any claim whatsoever in this respect. However, the income tax or any other tax which is as per the rules of the Govt. of India shall be deducted at source from monthly bills of the successful tenderer, as per rules/ instructions made applicable from time to time by government.

18. Director, ICAR-IIMR reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the Institute, for any justifiable reasons and it is not mandatory to be communicated to the tenderer.

19. Decision of Director, ICAR-IIMR shall be final for any aspect of the contract and binding to all parties. Discrepancies, if any, on the contract will be settled at his level by mutual consultation and in case of failure in settlement ICAR-IIMR, shall be referred to the sole arbitrator to be appointed by the ICAR-IIMR. The decision of the sole arbitrator so appointed shall be final and binding on the parties. Arbitration proceeding shall be governed by the Arbitration & Conciliation Act, 1996 as amended from time to time.

20. Acceptance by the Institute will be communicated by fax/telegram/email, express letter or any other form of communication. Formal letter of acceptance and work order of the tenderer will be forwarded as soon as possible, but the earlier instructions in the fax/ telegram, express letter etc. should be acted upon immediately.

21. The Institute does not pledge itself to accept the lowest or any other tenders and also reserve to itself the right of accepting the tenders whole or in part keeping in view valid reasons. Conditional tenders will not be accepted.

22. The Institute in its capacity as Principal Employer reserves the right to modify any of the terms and conditions of the contract as mentioned in the Schedules III of this document, at its discretion, in the interest of the job work.

23. Successful bidder/tenderer will have to enter into a detailed contract agreement with ICAR-IIMR on non-judicial stamp paper of Rs. 100/- (One hundred only) for work.

24. Successful bidder shall not transfer its right or sublet the contract to anyone else.

- 1 The supporting/allied services staff should follow strict attendance and alternative arrangements are to be made by the agency whenever anyone of staff/supervisor is to go on leave under intimation to this office.
- 2 Changing of Staff/Supervisor should be intimated to the designated officer of ICAR-IIMR, Hyderabad.
- 3 The Director, ICAR-IIMR reserves the right to reject any or all quotations in whole or in part without assigning any reason thereof. The decision of Director shall be final and binding on the Contractor/Agency in respect of clause covered under the contract.
- 4 The staff provided should also maintain secrecy and discipline in the premises of IIMR.

In case any of the personnel so provided is not found suitable by the IIMR, the IIMR, shall have the right to ask for his replacement without giving any reason thereof and the agency shall on receipt of a written communication will have to replace such persons immediately.
10. Payment for service contract will be made monthly upon submission of pre-receipted bill.

12.
